P25/02/09 To receive and approve apologies for absence. Cllrs Hay and Chesterton.

P25/02/10 Minutes for the planning committee meeting held 27th January 2025 (appendix V) for approval. Cllr Mann proposed these be approved, seconded by Cllr Gardiner and agreed by all but Cllr Stenning who abstained due to being absent from the meeting.

P25/02/11 Matters arising from the minutes. None.

P25/02/12 Declaration of Interests. None.

P25/02/14 a) Planning Applications to be considered – None.

b) Planning Decisions from EDDC:

24/2551/FUL Building And Land Adjacent 4 Prospect Terrace Sidmouth Road Colyton - Conversion and extension of an existing building into 1 dwelling and associated works. Approved with conditions.

24/0453/LBC Flat Above Flix Hair Design Market Place - Replacement 1 window with timber frame window at first floor on east gable elevation and the slating over and retention of existing flue to fireplace, following the removal of a chimney stump from the gable end of the east wing. Approved with conditions.

24/2209/DOC Barn East Of Hooperhayne Colyton - Discharge of condition for 24/0271/LBC: Condition 3.

24/1412/FUL & 24/1413/LBC Methodist Chapel King Street Colyton - Removal of existing shed structure and creation of new glazed link between chapel and side chapel; creation of opening in chapel to provide access to new glazed link between chapel and side chapel; creation of raised platform for kitchen and installation of mezzanine level at western end of chapel; enlargement and alteration of door openings in western end of chapel; demolition of wall existing wall and installation of new doorway and glazing into courtyard; blocking up of opening between side chapel and rear extension; repair of windows in principal elevation; replacement of existing windows in main chapel and side chapel; alterations to ridge height and pitch of existing rear extension and addition of flat roof single storey extension and demolition and partial rebuilding of boundary wall to front to provide parking. Approved with conditions.

c) Planning Correspondence

Comment for the EDDC Local Plan to be approved for submission. Cllr Parr circulated a first draft which was discussed, notes were added and a second draft will be presented at the next meeting for approval.

Notification received from EDDC informing the Parish Council that they will be discussing a planning application for Land Adjacent To Harepath Road Seaton. This is for Outline planning application (with details of access to be considered and all other matters reserved) for mixed use development comprising of up to 130 dwellings to the east of Harepath Road and the laying out of a new community football pitch, parking and welfare facilities to the west of Harepath Road, formation of accesses on Harepath Road and Colyton Road, public open space and other associated infrastructure. The meeting will be held on 25th February from 2pm at Blackdown House. If the Parish

Council wishes to send a member to speak on this application then they must register their wish to speak on an application from 10am on Tuesday 18 February up until 12 noon on Friday 21 February. Cllr Arnott will be present and will be speaking, he confirmed that he shared the same concerns as the Parish Council.
